**INCLUSION OF GROUP 'C' EMPLOYEES
UNDER ROTATIONAL TRANSFER POLICY - REGARDING**

1. The policy on deployment of Group 'A' & 'B' employees in DGAQA organisation was issued by MoD, DDP vide I.D. No. 60011/DGAQA/14/2016 D(HAL-III) dated 31.10.2016. However, the Group 'C' employees and some other posts in Group 'A' & 'B' of minuscule strength were kept out of the purview of the rotational transfer policy (RTP).
2. The guidelines for considering applications for posting/transfer from employees who are not covered under the above RTP was issued vide letter F. No. 3598/P&T/DGAQA/Admin-I dated 22 Nov 2017.
3. During the 22nd meeting of the 12th term of III level JCM Council held at OAQA, Trichy on 28.9.2018, Shri RN Ojha, Member Staff Side suggested that the RTP should be made applicable in respect of all the Gp 'C' employees to provide them exposure to work at different stations under different working atmosphere. After deliberations and with the approval of the Chairman, it was agreed that comments on this point may be invited from all FEs/Units and Staff Side members.
4. In view of the above, Heads of all FEs are requested to forward their comments on the above point so as to reach this HQrs by **21st December, 2018**.
