**Periodic Review of Central Government Employees for strengthening of administration under Fundamental Rule FR 56(j)/(l) and Rule 48 of CCS (Pension) Rules, 1972**

1. Reference DoP&T O.M. No. 25013/03/201 9-Estt.A-IV dated 28.08.2020 and this HQr letter No. 3513/Review/DGAQA/Admin date 11.09.2020.
2. Lists of Gp A, B, & C officers whose review case has already completed during the period July 2021 to June 2022 is enclosed with this letter (Annexure- A, B, C and D). It is requested that those cases which are already completed in past years may not be forwarded to this HQr again.
3. However, DoP&T vide above referred OM has also clarified that there is also no bar on the Government to review any such case again where it was decided earlier to retain the officer, but the Appropriate/Appointing Authority is of the opinion that it is expedient to undertake the review again on account of changed circumstances, in public interest. In this regard Para 6 & 7 of DoP&T OM dt 28.08.2020 also refers.
4. Heads of all FE/units are again requested to ensure that the requisite inputs in the prescribed proforma may be sent to this HQr for placing it before the Review Committee by **07<sup>th</sup> day of the first month of the quarter** in which review is falling due as per the 'Time Schedule' mentioned in Para 4 of above mentioned DoP&T O.M. dated 28.08.2020.
