**GRANT OF NON-FUNCTIONAL UPGRADATION (NFU) TO THE OFFICERS OF
DEFENCE AERONAUTICAL QUALITY ASSURANCE SERVICE TO THE SECOND
GRADE OF SENIOR TIME SCALE(DY SECRETARY LEVEL) IN LEVEL 12 IN THE
PAY MATRIX FOR THE YEAR 2022**

1. The approval of Competent Authority is conveyed to the grant of Non-Functional Upgradation (NFU) to the eligible officers of Defence Aeronautical Quality Assurance Service (DAQAS) to the Second Grade of Senior Time Scale (Dy Secretary level) in Level 12 in the Pay Matrix as per the details given at **Annexure-I**.
2. The up-gradation granted under these orders will be a purely non-functional up-gradation, personal to the officers concerned and it would not bestow any right to the officer to claim promotion or deputation benefits based on non-functional up-gradation.
3. Pay fixation on grant of non-functional up-gradation under these orders will be done as per the provisions of Civilians in Defence Services (Revised Pay) Rules, 2016. The officer(s) can exercise option regarding date of fixation in the higher grade/scale as provided in these Rules.
4. As and when the normal vacancies in the grade arise, the officers will be considered for regular promotion as per the normal DPC guidelines, based on the provisions of the Recruitment Rules. However, at the time of promotion, the pay in the grade will not be fixed again for officers who have been granted up-gradation under these orders.


