

**GRANT OF NON-FUNCTIONAL UPGRADATION (NFU) TO THE OFFICERS OF
DEFENCE AERONAUTICAL QUALITY ASSURANCE SERVICE
TO THE GRADE PScO(NF) (DY SECRETARY LEVEL)
IN LEVEL 12 IN THE PAY MATRIX**

1. The approval of the Competent Authority is conveyed to the grant of Non-Functional Upgradation to the eligible officers of Defence Aeronautical Quality Assurance Service (DAQAS) to the grade of PScO(NF) (Dy Secretary level) in Level 12 in the Pay Matrix as per the details given at **Annexure-I**.
2. The up-gradation granted under these orders will be a purely non-functional up-gradation, personal to the officers concerned and it would not bestow any right to the officer to claim promotion or deputation benefits based on non-functional up-gradation in such a manner.
3. Pay fixation on grant of non-functional up-gradation under these orders will be done as per the provisions of Civilians in Defence Services (Revised Pay) Rules, 2016.
4. The officers can exercise option regarding date of fixation in the higher grade/scale as provided in the Civilian in Defence Services (Revised Pay) Rules, 2016.
5. As and when the normal vacancies in the grade arise, the officer will be considered for regular promotion as per the normal DPC guidelines, based on the provisions of the recruitment rules. However at the time of promotion, the pay in the grade will not be fixed again for officers who have been granted up-gradation under these orders.
6. The above Non-Functional Upgradation will be further subject to the terms and conditions issued by the Govt. from time to time.
